MEETING MINUTES Pittsburgh Area ACI Chapter January 26, 2021

Members of the Board: Dave Thomas (Chair), Josh Bryan, PJ Donoghue, Dominic Giovannucci, Tricia Ladely, Bob Lawrence, Brian Lucarelli, Carly McGee, Ryan Pendeville and Steve Reed

1. Administrative

a. Bryan motioned to approve the 11-19-20 minutes; Lawrence seconded. The motion had unanimous approval.

2. New Business

- **a.** Our checking account has a current balance of \$1,626. Reed motioned to transfer \$20,000 from our investment account into our PNC account. Lawrence seconded. The vote was unanimous.
- **b.** Sponsorship of the ACI Spring Virtual Convention Donoghue motioned to sponsor at the \$500 level. Ladely seconded. The motion had unanimous approval.
- c. Mission Statement After some deliberation, the following statement was agreed upon: The mission of this chapter is to teach, train, gather, and share information to guide and support the concrete construction industry in the Greater Pittsburgh Region. Donoghue motioned to implement this statement. Pendeville seconded. The motion had unanimous approval.
- d. Jeff Graves, our webmaster from ID Productions, proposed a redesign to our Chapter website. He said we are working with an older theme that has its limitations, and he feels it would be beneficial to modernize the look of the site. His cost to do so would be \$1,600. Ladely expressed that if we want to increase member participation in the Chapter, and its activities, that we should consider both website redesign and marketing efforts at the same time. She also felt that we should gather two more proposals. Bryan commented that we need to decide what we want the goal of our website to be before asking for proposals. He suggested that each board member email three "functions" that they felt the Chapter website should provide and then we will proceed with the effort.
- e. The 2021-2022 election process was discussed. Dave Thomas has finished his term as President and has agreed to serve as Past President. Steve Reed expressed that his time is limited, and for that reason, he would not be able to efficiently serve as Chapter President at this time. In addition, three board member terms are ending (Bryan, Giovannucci and Lawrence). Rader will send an email to the membership stating that we need candidates for these seats. It will be noted that the President and VP seats, require the members to have previously served on the Board of Directors. Deadline for nominations will be March 1, 2021.

3. Old Business

- **a. Anti-Harassment Policy –** Donoghue motioned to approve the policy that Bryan had drafted. Ladely seconded. The motion had unanimous approval.
- **b.** PA REV-72 Form The application was mailed to the PA Department of Revenue on 1/7/2021, but it was not delivered by the post office until this past Saturday, 1/23/2021. The next steps will be for the State to begin processing the application.

- c. Engineering is Everywhere Curriculum Lucarelli stated that he had spoken to Dan Gottron from McGuffey School District about this program. He explained that our Chapter planned to conduct a pilot study and provide the curriculum and teaching material for these classes. Gottron asked that Lucarelli send him an email with the details of the study and he would share with other schools who would have interest in this program. The cost will be about \$500 per class. We plan to conduct 1-5 classes, depending on the interest.
- **d.** Last month there was a question about the tax implications if we withdraw money to use for sponsorship/educational purposes. Tyler Falk, our representative from Centauri, investigated and said since we are a non-profit, there would be no capital gains taxation.
